



MULIT-COUNTY NEW LANDOWNERS SEMINAR SERIES

The Multi-County New Landowner Education program is a series of eight informational meetings/seminars/field days designed to make new landowners in Austin, Colorado, Fayette & Washington Counties aware of what types of agricultural enterprises are best for their property. Participants in the program will hear from experts in certain fields of agriculture about the best management practices that they can implement on their own property. This innovative program assists new landowners in understanding the concepts of rural living. Participants in the program are given exposure to ideas on raising livestock and horses, plant identification, fence building, applying pesticides, soil testing, stock pond management, pond construction, fruit and nut production, and much more. The program also serves as a way for new residents of the four counties to network and meet new people in their communities, find out what can be done on their land, what operations can be profitable, and possibly what opportunities they have to serve the community. Program will be held on the third Friday's of the months of February, March, April, May, August, September, October and November. Each month's meeting will be held at different locations in each county. The meetings begin at 12:30 p.m., with registration and last until 5pm. Urban & Homeowner Soil Campaign Jan. 25-Feb 26th

The Urban & Homeowner Soil Testing Campaign is underway in Austin County and will run January 25 – February 26. This campaign is made possible through the support of the Multi-County Ag Committee and in cooperation with the Texas A&M AgriLife Extension Soil, Water, and Forage Testing Lab in College Station.

Soil sample bags and submittal forms for the soil testing campaign are available at six locations including: Bellville - Texas A&M AgriLife Extension Service-Austin County (800 E. Wendt St), Harrison's Farm Service, Linseisen's Feed & Supply Inc; Sealy - Steinhauser's; New Ulm - Dudensing Farm Service; and Industry – Lindemann's Store.

All soil samples, forms, and payment must be returned to the Austin County Extension office to receive the discounted pricing. Full payment by <u>check payable to MCAF</u> is due when the samples are submitted to the Extension Office. Extension Office will deliver your samples to the testing lab. Sample results will be returned to the County Extension Office and then distributed to submitters via email or regular mail.

This Soil Testing Campaign offers homeowners and gardeners the opportunity to have their soil tested to determine its current fertility and receive a recommendation to improve the fertility required to maintain and produce the best possible outcome for their garden, lawn, or landscape. This campaign is only intended for soil analysis on non-agricultural land; only samples from lawns, landscapes, and gardens will be accepted.

The cost for a routine analysis will be \$8.00 and a routine analysis with micronutrients will cost \$15.00.

In exchange for the reduced testing cost, some information regarding your management practices will be asked on the soil testing form. The information you will be asked to provide includes the last time the area was fertilized, a description of previously used fertilizers, and whether or not the soil has been sampled in the past.

SPRAY PERMITS REQUIRE D FOR A PORTION OF AUSTIN COUNTY

As a reminder to anyone that will be using state limited use or state restricted use herbicides in Austin County, a permit to apply these herbicides must be obtained through the Texas Department of Agriculture if you plan on spraying in certain portions of the county. The following areas of Austin County must acquire a permit as is specified in the Texas Agricultural code, chapter 75,

- 1.) Only portion of Austin County lying east & south of the line beginning at the point where State Highway 36 crosses the north county line, thence southerly along Highway 36 to FM 949; thence westwardly along FM 949 to the San Bernard River
- 2.) Between March 15th and July 31st, in that portion of Austin County lying south of Interstate Highway 10, the following restrictions on the use of 2,4-D formulations shall apply:
 - (A.) The application by aircraft is prohibited
 - **(B.)** The use of all ester formulations by any method is prohibited
