

## Hay Show Samples Extended

Beef & Forage Committee of Austin County is encouraging beef cattle producers to turn in a sample of their hay for analysis at the Austin County Extension office. The deadline has passed but samples are being accepted until September 13th. The analysis will give producers very useful information about the quality of the hay they are feeding to their livestock, and the test will help them determine what additional level of supplements may be needed during the winter. Tests will show the crude protein level, total digestible, and acid detergent fiber (ratio of leaf to stem). Testing campaign and Hay Show is open to any hay producer from Austin or surrounding counties. Producers may submit as many samples as they wish for analysis in each of the following categories:

- 1) **Improved (Hybrid) Bermudagrass** (Except T-85) (e.g., Coastal, Jiggs, Alicia)
- 2) **Other Bermudagrasses** (e.g., Common Bermudagrass, Tifton 85)
- 3) **Warm Season Annual Grasses** (e.g., Rice Straw, Hay Grazer, Sudan Crosses, Sorghum Alum)
- 4) **Other Warm Season Perennial Grasses** (e.g., Eastern Gamagrass, Bluestem, Johnsongrass, Kleingrass, Bahiagrass)
- 5) **Cool Season Grasses** (e.g., Wheat, Oats, Cereal Rye, Ryegrass)
- 6) **Legumes** (e.g., Clover, Peanut, Cowpea)
- 7) **Legume/Grass Mixtures** (e.g., Rye/Clover, Oats/Vetch)

We use these samples to help put on the Youth Forage contest at the Austin County Fair. Sample(s) help us to put on a great contest for the youth. Texas A&M AgriLife Extension will host a Texas Olive Update & Grower's Seminar on September 30<sup>th</sup> in Uvalde, Texas. This half-day educational event will provide an update on the status of the Texas olive industry and research efforts regarding olive production in Texas. Lessons learned over the past 25 years of commercial olive production in Texas will be shared, setting the stage for what the future of the industry might look like. Challenges of olive production will be discussed in detail, along with findings and recommendations to mitigate these challenges. Attendees will also hear presentations on the results of research on olive cold-hardiness and disease resistance. Findings from 6 years of coordinated olive variety trials across Texas will be discussed, and there will be a tour of one of these trials on-site. The program will conclude with discussion on the best practices for olive and olive oil production in Texas. The event will be held at the Texas A&M AgriLife Research & Extension Center at Uvalde; doors will open at 8am and the program will conclude at 1pm. There is no charge to attend and registration is not required but RSVP is requested. The event is geared toward commercial production but is open to everyone. # AUSTIN COUNTY HOG BOUNTY

Austin County Commissioners Court is offering a bounty on feral hogs. Participants will be awarded \$5 per feral hog harvested in Austin County, with biological evidence provided of harvest in the form of a pair of feral hog ears. Each pair must be placed in an individually sealed bag and dropped off at 1 of the 3 drop off locations. Three local feed stores in the county, Steinhauer's in Sealy, Linseisen's Feed & Supply in Bellville, and Lindemann Store in Industry, will serve as the drop off locations.

A limit of 20 pairs per household per month is allowed. All feral hogs must be harvested in Austin County & signed paperwork must be filled out completely to collect money.

# Austin County Pecan Show Entries Due 11/28

Annual Pecan Show will be held on Thursday, December 1, 2022, at the Texas A&M AgriLife Extension Office located at 800 E Wendt St, Bellville, TX 77418. There will be a short educational program followed by an awards presentation.

Entries for this year's show must be delivered to the AgriLife Extension Office during normal business hours, 8:00 am to 12:00 pm (Noon) and 1:00 pm to 5:00 pm, beginning Tuesday, November 1st through Monday, November 28th. All entries must be submitted by 5:00 pm on Monday, November 28th to be entered in the show.

Each entry must be in a brown paper bag (provided at the office) and an entry card filled out. Individuals may make as many entries as they wish of different pecan varieties, and each entry must consist of 50 pecans of the same variety. There is no fee to enter. Anyone from Austin County may enter or anyone from a surrounding county that does not have a county pecan show.

Ten (10) pecans will be randomly selected by the Committee for judging. Included in the judging will be kernel weight percent, color, fill and blemishes. Top placing pecans from all entries that qualify will be forwarded on for judging at the regional pecan show and from there to the state contest.

2022 Texas Fruit Conference is a two-day hybrid educational program in New Braunfels, TX, September 26 & 27th. A half-day “Intro to Fruit Growing” workshop will teach new and inexperienced fruit growers how to start an orchard successfully. A main educational conference offers current and advanced topics aimed at improving/enhancing economic sustainability through orchard management, innovation, and diversity. A “Taste of Texas Fruit” networking reception will feature Texas-grown fruit and prepared fruit-themed snacks and beverages. Texas Pesticide License CEU’s offered (3.0 to 5.0 TBD), by Texas Department of Agriculture. Audience is prospective and established growers of perennial fruit crops (peaches, blackberries, figs, etc.) who have commercial, serious recreational, or public service interest in growing fruit in Texas (master gardeners, community/school gardeners, etc.). ## Multi-County New Landowners Series 2022

The Multi-County New Landowner Education program is a series of 7 informational meetings, seminars, and field days designed to help new landowners in Austin, Colorado, Fayette, & Washington Counties become aware of what types of agricultural enterprises are possible for their property. Participants in the program will hear from experts in a variety of fields in agriculture about best management practices that can be implemented in the area. This innovative program assists new landowners in understanding the concepts of rural living. Participants in the program are given exposure to ideas on raising livestock and horses, plant identification, fence building, applying pesticides, soil testing, stock pond management, pond construction, fruit and nut production, rainwater harvesting, turf management, and much more. The program also serves as a way for new residents of the four counties to network and meet new people in their communities, find out what can be done on their land, what operations can be successful, and possibly what opportunities they have to serve the community.

The programs will be held on the ***third Friday of the months of August through November***. Each month's meeting will be held at different locations in one of the four counties. The meetings begin at 1:30 pm and will last between 4 and 5 hours depending on the topic and possible tour stops. The cost for the program series is \$125.00 per person, \$200.00 per couple for all seven meetings, or \$20.00 per person per meeting. Continuing Education Units (CEU's) for pesticide applicators will be offered as they are applicable. A great selection of refreshments will be provided at each session. Participants who sign up for the **entire series** at the beginning will receive a notebook to fill out as they progress through the program. It will include handouts and reference material that will be useful as they move forward with improvements on their property. The remaining topics to be covered for this year are:

- **September 16<sup>th</sup>** – Forage and/or Livestock Production – Options for Small Acreage Operations
- **October 21<sup>st</sup>** – Wildlife Management and Native Prairie Restoration
- **November 18<sup>th</sup>** – Bees and Trees for Homeowners

## RENEWAL UPDATE FOR 2022 APPLICATOR LICENSE HOLDERS

In response to the ongoing Covid 19 pandemic, the Texas Department of Agriculture (TDA) is extending the exemption of agriculture Continuing Education Unit (CEU) requirements. To address the CEU's and licensure requirements for Ag Pesticide applicators, the TDA will work with the ag pesticide applicators and CEU course providers of Texas during this critical time. Licensed applicators with expiring licenses or needing CEU's will be allowed to renew their license even if they have not met their CEU requirement for their current licensing period through December 31, 2022. Due to the uncertainty of the length and severity of the Covid 19 pandemic, many CEU events have been canceled. The TDA will work to insure all the state's pesticide applicators are able to acquire their licenses and required continuing education courses in a safe and effective manner during this time frame. Once CEU courses resume as normal, applicators will be required to obtain their required CEUs for their respective license classification for each licensing period. By allowing a CEU exemption, the applicators maintain their ability to perform pesticide applications for pests, weeds, insects etc., without disrupting daily business functions. Applicators are encouraged to complete online courses even if online courses were completed the previous licensing period.

**COMMERCIAL, NON-COMMERCIAL AND NON-COMMERCIAL POLITICAL APPLICATORS** For licenses expiring in 2022 ONLY: TDA will exempt commercial, non-commercial and non-commercial political applicators who have taken online or correspondence courses within the last year. The TDA Rule 7.24 (t) (2) does not allow for online or correspondence courses to be taken 2 years consecutively. However, in light of the unusual circumstances due to Covid 19 (coronavirus), the TDA will allow online or correspondence courses to be taken in consecutive years. This exemption will be for the current 2022 licensing period. Commercial, non-commercial and non-commercial political pesticide applicators are required to obtain 5 CEUs per licensing period.

**PRIVATE APPLICATORS** For licenses expiring in 2022 ONLY: The TDA will also exempt private applicators from the TDA Rule 7.24 (v) (5). This rule does not allow a private applicator to acquire more than 10 CEUs through correspondence courses. During this quarantine time frame, private applicators will be allowed to acquire ALL of their CEUs through correspondence courses (online). Private applicators are required to obtain 15 CEUs per 5- year licensing period.
