

Commissioner Sid Miller Supports Rural Mental Health
Awareness ~ Texas Department of Agriculture

AUSTIN — Texas Agriculture Commissioner Sid Miller has united with country music artist Jenna Paulette to encourage rural Texans to make mental health a top priority. Texas farmers and ranchers face an increased risk for suicide and mental health challenges. This is often due to social and geographical isolation, weather variability such as extreme droughts or flash floods, limited access to health services, and fluctuating commodity prices. The Texas Department of Agriculture's AgriStress Helpline provides 24/7 support to these individuals who are struggling and may need help.

"Even the toughest people need help sometimes," said Commissioner Miller. "Not only does the agriculture industry have some of the highest rates of fatalities and injuries across all age groups, but also some of the highest rates of suicide. TDA's AgriStress Helpline is a great resource for Texas farmers and ranchers to go to for support tailored specifically to the agriculture industry."

TDA's AgriStress Helpline is a free and confidential crisis and support line that anyone struggling with challenges can call or text 24/7. While there are a handful of agricultural resource and referral lines out there, this is the only crisis support line currently dedicated to agricultural, forestry, and fishing communities with interpretation services that are provided in 160 languages.

As a Texas rancher, Jenna Paulette knows mental health resources are crucial for Texas farmers and ranchers. Her new music video "You Ain't No Cowboy" depicts the struggles of a man who is wrestling with the demands and pressure of his daily life and seeks help. As the storyline continues, he works out his issues for the sake of his family and livelihood. Through her music video, Jenna Paulette aims to detach Hollywood's negative representation of the cowboy by redefining the image of a cowboy as hardworking, loyal, and loving. This narrative hits close to home for the country music singer, who has witnessed a loved one struggle with mental health firsthand.

"The power to change and have a full life is there for the taking, you're just a decision away from a redeemed life. This video is a call to action for those suffering and the end is a glimpse of hope into the life of a real man who is on the other side of adversity," said Jenna Paulette. "The cowboys in my world, including Ross, the love of my life, have overcome many challenges. Ross is 5 years sober and he plays the cowboy in the video. I met him after he beat his addiction. He made a conscious decision to take his life back and with grace and the strength of God, good men, and family around him he was able to do it."

"There is a stigma around stress and mental health in the agriculture community," Miller stated. "It's time we put an end to the notion of this shame and prioritize our mental health. I urge all Texans to invest in their overall well-being by reducing stress levels, staying active, eating healthful meals, and talking to someone if you have concerns or worries."

Soil Campaign November 1-22nd

Growing better quality hay and pasture grass is a major goal of all hay and livestock producers. Starting with a soil test is the most important step in determining the amount and type of fertilizer needed each year. Producers should consider soil testing as an investment in this year's hay and pasture because the correct amounts and timing of fertilization can greatly enhance hay quality and growth.

November 1st through November 22nd has been set as the time for all Austin County landowners to participate in the soil testing campaign for this year's hay meadows and pastureland. The Beef & Forage Committees of Austin and Colorado Counties are sponsoring the soil test drive and encouraging producers to participate. Soil samples submitted during this time frame will be \$8.00 for a routine analysis and \$15.00 for a routine analysis including micronutrients. Samples along with payment may be turned in to one of the following locations around Austin County: Bellville – Texas A&M AgriLife Extension Service of Austin County (located at 800 E Wendt St), Bellville Farm & Ranch, and Linseisen's Feed & Supply Inc; Sealy – Steinhauer's; Cat Spring – Bernardo Farm & Ranch Supply; and Industry – Lindemann's Store. Soil sample bags and information forms for sampling are available at each of these locations.

Feathers, Furs, and Farming – Wildlife Tax Valuation

Texas A&M AgriLife Extension Services in Austin and Colorado Counties are partnering with Texas Parks and Wildlife to host a Feathers, Furs, and Farming program on December 15, 2023. The focus of this program will center around Wildlife Tax Valuation. Topics covered will include Proposition 11, Wildlife Tax Valuation, Controlling Unwanted Brush, and Predator Control. Two general CEUs will be offered for TDA Pesticide Applicators.

The event will be held at the Weimar Civic Center located at 1754 IH-10, Weimar, TX 78962. Registration will be from 1:00 - 1:30 pm with the program beginning at 1:30 pm and concluding at 5 pm. Cost of attendance is \$15 per person or \$20 per couple.

PECAN SHOW/AWARDS & PROGRAM

Do you have a pecan tree in your front or back yard? Not sure what variety it is? You do not need to own a pecan orchard to participate in the Annual Austin County Pecan Show. If you live in a neighboring county and your county does not host a pecan show, you are also eligible to enter the Austin County Pecan Show.

The Horticulture Committee of Austin County will host its Annual Pecan Show on Thursday, November 30, 2023, at the Texas A&M AgriLife Extension Office located at 800 E Wendt St, Bellville. There will be a short educational program starting at 6 pm followed by an awards presentation. This year's Pecan Program will feature Dr. Monte Nesbitt, AgriLife Extension Horticulture Program Specialist. Dr. Nesbitt will be discussing the following topics: Processing Pecans-Field to Plate and Storage of Pecans. The educational and awards program is open and free to the public, even if you did not enter pecans into the show.

Entries for the show must be delivered to the AgriLife Extension Office during normal business hours, 8:00 am to 12:00 pm and 1:00 pm to 5:00 pm, beginning Wednesday, November 1st until Monday, November 27th. All entries must be submitted by 4:00 pm on Monday, November 27th to be entered in the show.

Each entry must be in a brown paper bag (provided at the office) with a completed entry card. Individuals may make as many entries as they wish of different pecan varieties, and each entry must consist of 50 pecans of the same variety. There is no fee to enter or age limit. Entries will be accepted from residents of Austin County or surrounding counties that do not have a county pecan show.

Ten (10) pecans will be randomly selected by the committee for judging. Included in the judging will be kernel weight percent, color, fill, and blemishes. Top placing pecans from all entries that qualify will be forwarded on for judging at the regional pecan show and from there, to the state contest held in July. Pecans not being forwarded to the regional show may be picked up at the AgriLife Extension Office on Thursday, November 30th after the awards presentation.

For the Educational and Awards Program, we do encourage you to RSVP since we will be providing dinner. Please RSVP by Tuesday, November 28th.

The Bluebonnet Master Gardener Association (BMGA) announces that registration is open for its 2024 Master Gardener Certification Training Class to be held in Brenham. The class is open to participants from Austin, Colorado, Fayette, and Washington Counties, and will provide 50+ hours of gardening education from experts in various fields of horticulture.

This is a unique opportunity for individuals who are interested in horticulture and serving their community. Master Gardeners are trained in all facets of horticulture such as plant & soil science, entomology, plant pathology, fruit and vegetable gardening, and much more. Upon completion of their training, Master Gardeners are required to give at least 50 hours of volunteer service time in their local community to receive the title of “Master Gardener”.

The 2024 BMGA training class will be held every Wednesday, January 10 to April 24, 2024, from 8:30 am to 12:30 pm, at the Washington County Expo Event Center, 1305 East Blue Bell Road, Brenham, TX 77833. Field trip days may run to 3:30 pm. The registration fee is \$200 per person, which includes the Master Gardener Handbook compiled by the Texas Master Gardener Association in conjunction with Texas A&M AgriLife horticulture specialists. The purpose of this training is to obtain a Private Applicator License from Texas Department of Agriculture (TDA). This license will enable the applicator to purchase and apply state limited use and federally restricted chemicals on his land or land he has control of for the purpose of production of agricultural commodities. All farm and ranch operators who do not have a Private Applicator's License to purchase "restricted use" pesticides (such as 2, 4-D, Grazon P+D, Tordon 22K, etc.) will need to attend this training.



All Ag/Timber numbers currently held will expire on December 31, 2023. You must renew your number to continue to claim an exemption on qualifying agriculture and timber purchases made after that date. The Comptroller's Office mailed out renewal letters during the month of August 2023 to the mailing address on file. You may renew your Ag/Timber number at that time.

Ag/Timber Numbers must be renewed every four years, regardless of when the number was first issued. Renewed and new Ag/Timber Numbers expire Dec. 31, 2023.

You must enter the expiration date on the exemption certificate you give to retailers on your qualifying purchases. If you already have an exemption certificate on file that includes your Ag/Timber Number, you can add the expiration date to the exemption certificate and initial it for the retailer's records.

AUSTIN COUNTY HOG BOUNTY

The Austin County Feral Hog Bounty is still going on! The Bounty program is offered with the support of the Austin County Commissioners Court. Participants will be awarded \$5 per feral hog harvested in Austin County, with biological evidence provided of harvest in the form of a pair of feral hog ears. Each pair must be placed in an individually sealed bag and dropped off at 1 of the 3 drop off locations. Three local feed stores in the county - Steinhauser's in Sealy, Linseisen's Feed & Supply in Bellville, and Lindemann Store in Industry - will serve as the drop off locations.

A limit of 20 pairs per household per month is allowed. All feral hogs must be harvested in Austin County & signed paperwork must be completed when dropping off the ears to collect the bounty.
