

## 5 HR CEU Recertification Conference

As a reminder to anyone with a TDA Private Applicator License, you need 15 Continuing Education Units (CEUs) to re-certify every 5 years, 2 hours in Laws & Regulations and 2 hours in Integrated Pest Management, with 11 hours in the General Category. All TDA Commercial and Non-Commercial Applicator License holders need 5 CEUs every year to re-certify with 1 hour in Laws & Regulations, 1 hour in Integrated Pest Management, and 3 hours in the General Category.

Anyone needing hours should mark Friday, December 8, 2023, on their calendar. The Beef & Forage Committee of Austin County will be hosting a 5-Hour CEU Conference at Four County Auction Center located at 11942 HWY 159 in Industry. Registration will take place at 12:30p.m., with the program starting at 1:00p.m. The registration fee is \$50.00. We encourage you to pre-register for the program, so we have enough program materials, but walk-ins are welcome. ## Agriculture & Timber Sales Tax Exemption Expiration Update

All Ag/Timber numbers currently held will expire on December 31, 2023. You must renew your number to continue to claim an exemption on qualifying agriculture and timber purchases made after that date. The Comptroller's Office mailed out renewal letters during the month of August 2023 to the mailing address on file. You may renew your Ag/Timber number at any time between now and December 31.

Ag/Timber Numbers must be renewed every four years, regardless of when the number was first issued. Renewed and new Ag/Timber Numbers expire December 31, 2023.

You must enter the expiration date on the exemption certificate you give to retailers on your qualifying purchases. If you already have an exemption certificate on file that includes your Ag/Timber Number, you can add the expiration date to the exemption certificate and initial it for the retailer's records.

## AUSTIN COUNTY HOG BOUNTY

The Austin County Feral Hog Bounty is still going on! The Bounty program is offered with the support of the Austin County Commissioners Court. Participants will be awarded \$5 per feral hog harvested in Austin County, with biological evidence provided of harvest in the form of a pair of feral hog ears. Each pair must be placed in an individually sealed bag and dropped off at 1 of the 3 drop-off locations. Three local feed stores in the county - Steinhauer's in Sealy, Linseisen's Feed & Supply in Bellville, and Lindemann Store in Industry - will serve as the drop-off locations.

A limit of 20 pairs per household per month is allowed. All feral hogs must be harvested in Austin County & signed paperwork must be completed when dropping off the ears to collect the bounty.

## 2024 BLUEBONNET MASTER GARDENER INTERN CLASS

The Bluebonnet Master Gardener Association (BMGA) announces that registration is open for its 2024 Master Gardener Certification Training Class to be held in Brenham. The class is open to participants from Austin, Colorado, Fayette, and Washington Counties, and will provide 50+ hours of gardening education from experts in various fields of horticulture.

This is a unique opportunity for individuals who are interested in horticulture and serving their community. Master Gardeners are trained in all facets of horticulture such as plant & soil science, entomology, plant pathology, fruit and vegetable gardening, and much more. Upon completion of their training, Master Gardeners are required to give at least 50 hours of volunteer service time in their local community to receive the title of "Master Gardener".

The 2024 BMGA training class will be held every Wednesday, January 10 to April 24, 2024, from 8:30a.m. to 12:30p.m., at the Washington County Expo Event Center, 1305 East Blue Bell Road, Brenham, TX 77833. Field trip days may run to 3:30p.m. The registration fee is \$200 per person, which includes the Master Gardener Handbook compiled by the Texas Master Gardener Association in conjunction with Texas A&M AgriLife horticulture specialists. Applications are available online at <https://txmg.org/bluebonnet/> or at local county AgriLife Extension Offices. Class size is limited, so to ensure a spot in the 2024 BMGA Training Class, application and payment must be submitted online or delivered to the Washington County AgriLife Extension Office as soon as possible.





All farm and ranch operators who do not have a Private Applicator's License to purchase "restricted use" pesticides (such as 2, 4-D, Grazon P+D, Tordon 22K, etc.) will need to attend this training.




As a reminder to anyone that will be using state limited use or state restricted use herbicides in Austin County, a permit to apply these herbicides must be obtained through the Texas Department of Agriculture if you plan on spraying in certain portions of the county. The following areas of Austin County must acquire a permit as is specified in the Texas Agricultural code, chapter 75,

- 2) Between March 15 and July 31, in that portion of Austin County lying south of Interstate Highway 10, the following restrictions on the use of 2,4-D formulations shall apply:

(B) the use of all ester formulations by any method is prohibited.

Permits may be obtained from the Texas AgriLife Extension Service of Austin County at (979) 865-2072. Forms can also be obtained by contacting the Texas Department of Agriculture Gulf Coast Regional Office in Houston at (713) 921-8200.
